- 3. The stallion Mecom Bay Roan has been tested negative for: Herda and 5 Panel Tested by AQHA.
- 4. All sales are subject to availability and are final upon acceptance of this agreement. All fees are payable upon execution of this Agreement. Buyer specifically agrees and understands that no semen will be shipped until all fees have been paid.
- 5. There is no live foal guarantee.
- 6. Upon execution of this sales agreement and receipt of all fees the frozen semen becomes the property of the Buyer. Buyer agrees to pay storage fees associated

- with the frozen semen to the storage facility if delivery of the frozen semen is not taken within five business days.
- 7. Buyer is responsible for compliance with registry requirements for the use of frozen semen and payment of any fees for the subsequent registration of foals conceived.
- 8. The Buyer shall assume all responsibility for the condition and management of the mare and will bear all risk of loss or damage to the mare whether by death, disease, injury, infection, or otherwise, and by any cause whatsoever and therefore agrees to hold Seller or any person employed or associated with Wichita Partnership Ltd./Wichita Ranch harmless for any and all damages associated therewith.
- 9. Buyer is responsible for all shipping, tank rental and handling fees associated with delivery of the semen from the storage facility and return of the shipping container. Semen is stored and shipped by:
